OXNARD CITY COUNCIL Regular Meeting February 9, 2010

SUBJECT: Adoption of the Final Draft Oxnard 2030 General Plan (2030 Plan) (PZ 10-620-01) and Adoption of Statement of Overriding Considerations and Findings of Fact; Call of Special Election for Voter Adoption of Goals and Policies of the 2030 Plan and Amendment to the City Urban Restriction Boundary (CURB) for the Del Norte Community Extension (DNCE). (079)
RECOMMENDATION: (1) Hold a hearing to take public comments on the 2030 Plan; (2) Separately consider and finally decide the land use issues for the 107-acre parcel at 1853 Camino Del Sol; (3) Adopt a resolution adopting the Statement of Overriding Considerations and Findings of Fact related to the adoption of the 2030 Plan and adopting the 2030 Plan subject to voter adoption of the Goals and Policies thereof; and (4) Adopt a resolution calling a Special Municipal Election on June 8, 2010, to adopt the proposed Goals and Policies for the 2030 Plan including an amendment to the CURB to include the DNCE area and redesignation of land uses within that area, and requesting the Ventura County Board of Supervisors to Consolidate the Oxnard Special Municipal Election with the June 8, 2010 Statewide Primary Election.

The Development Services Director and Senior Planner reviewed past actions, background and time-line, and issues and options for consideration.

Councilmembers commended the Development Services Department on the time and work that was put into the Plan. They also expressed concerns with various elements of the document and asked that it be brought back at a later date.

DISCUSSION: The Development Services Director reviewed the reason for the change in size and the name of Jones Ranch to the Del Norte Extension.

The City Council commented on the need to review various details of the Plan, including: Ormond Beach development, SOAR boundaries, Agromin, power plants, school issues, and Local Coastal Plan. The Councilmembers concurred that a complete re-write was not necessary. Councilmember Maulhardt stated, for the record, "This is the General Plan that we're being proposed. There is some potential changes that might be done on it but it is in substance the one we have." He continues, "I also would like to comment on the SOAR. I said it, and we've all said it before: I think just about every other City has had a SOAR initiative vote already. The City of Oxnard has not had one. The SOAR initiative is very specific. It calls for a change if a change is wanted - an amendment - and I don't see why there would ever be an objection to allowing the voters to vote on that amendment. I think it does need to be a stand-alone amendment. But I don't see why there would be, if it is not accepted by the voters - which, some people in this room believe it will never be - then that's what it will turn out to be. But I don't see why there should be any reason not to, if there is a belief and there is a plan, to put it...to do something out there, that would be what's required, and it is very clear what the steps should be.
