OXNARD CITY COUNCIL
Regular Meeting
May 5, 2009

A. ROLL CALL/POSTING OF AGENDA

At 5:37 p.m. the regular meeting of the Oxnard City Council convened in the Council Chambers. Councilmembers Holden, Herrera, Maulhardt, and MacDonald were present. Councilwoman Pinkard was absent. The City Clerk stated that the agenda was posted on Thursday in the Library and City Clerk's Office. Staff members included: Ed Sotelo, City Manager; Alan Holmberg, City Attorney; Grace Magistrale Hoffman, Deputy City Manager; and Jill Beaty, Assistant City Clerk. Mayor Holden presided and called the meeting to order.

B. PUBLIC COMMENTS ON CLOSED SESSION ITEMS

C. CLOSED SESSION

At 5:45 p.m., based on existing facts and circumstances and on the advice of the City Attorney, the City Council recessed to a closed session, pursuant to Government Code section 54956.9(c), to decide whether to initiate litigation in one potential case. Councilwoman Pinkard was present.

The City Council also recessed to a closed session, pursuant to Government Code sections 54959 and 54957.6, to give instructions to negotiators, Karen Burnham, Assistant City Manager, and Michelle Tellez, Human Resources Director, regarding salaries, salary schedules or compensation paid in the form of fringe benefits for employees represented by the International Association of Firefighters AFL-CIO (IAFF) and the Oxnard Peace Officers' Association (OPOA) and other matters within the scope of representation.

At 7:10 p.m. the City Council reconvened and the Mayor read a statement that the City Council has determined to initiate litigation against the California Coastal Commission and Southern California Edison Company based on the Commission's decision to issue to Southern California Edison a Coastal Development Permit to construct a Peaker Plant adjacent to the existing Reliant Power Plant at 251 North Harbor Boulevard.

The City Treasurer's Office received the Certificate of Excellence award for its Investment Policy for Certification from the Public Treasurers Association; the City's receipt of 1) \$5 million in federal stimulus monies for the Rice Ave/Santa Clara interchange improvement project at Highway 101 which will improve Port of Hueneme trade corridor; and 2) \$400,000 gang and youth violence policy grant; AB 39 ruled unconstitutional, saving Redevelopment funds from being taken by the State.

R. STUDY SESSION

Public Works Department

- 1. SUBJECT: Federal Emergency Management Agency (FEMA) /Flood Insurance Rate Maps (FIRM) Public Outreach Program. (035)

RECOMMENDATION: Receive a verbal presentation from the Public Works Director on the status of the FEMA/FIRM Public Outreach Program and provide direction to the Director regarding the program.

DISCUSSION: The Public Works Director and Development Services Manager provided the update on three FEMA-related activities that affect the City: 1) Flood insurance rate map (Maps); 2) levee certification program; and 3) flood insurance study for Santa Clara River, affecting local Ventura County communities. Staff continues to actively review the Maps to ensure their accuracy and remove many properties from the Maps before they become affected. The Director discussed staff's recommendations to 1) pursue funding for closure of the "gap" in the levee; 2) work with elected officials to develop a strategy to extend a preferred insurance rate to City residents; and 3) target a Public Outreach Program campaign to obtain flood insurance before Maps are certified to grandfather in lower rates.

Bert Perello, Chair, South Bank Neighborhood, would like more specifics as to streets and neighborhoods.

Supervisor John Zaragoza expressed his and Supervisor Bennett's partnership with the City in efforts to continue working to minimize the impacts to residents.

William Terry, concern with gap in the floodplain.

The City Council commented: 1) on meeting with area representatives in Washington to lobby for City residents for assistance with the insurance and building of levy; 2) its appreciation to the capable staff for working on these issues.


