SUBJECT: Community Development Block Grant (CDBG) Youth Enrichment Program
Subrecipient Agreements for FY 06-07

RECOMMENDATION

That City Council:

1. Approve the allocation of \$68,597 in CDBG Youth Enrichment Program funds to three non-profit community based organizations: Camp Fire USA (A-6790 for \$15,000), City Impact Inc., (A-6791 for \$15,000) and Food Share, Inc. (A-6792 for \$38,597).
2. Authorize the City Manager to execute CDBG subrecipient agreements requiring such groups to provide enrichment programs that target at-risk youth from very low and low-moderate income families.

DISCUSSION

During City Council's consideration of the recommended FY 06-07 CDBG budget, Council approved the maximum amount allowable under CDBG regulations (15 percent of the entitlement plus program income) for appropriating to Public Service programs targeting at-risk youth. In keeping with Council's direction, the CDBG Public Services allocation provides for continued funding to the Police Activity League (PAL) (\$160,977), the Colonia Gymnasium (\$51,328), the Colonia Boxing Center (\$19,225), the After School Program (\$105,000), and City Corps (\$23,629)(see Attachment # 1). The remainder of the funds (\$68,597) set aside for youth are made available to non-profit community based organizations solicited through the Request For Proposal (RFP) process.

As part of the RFP process, a Citizens Ad Hoc Review Committee ("the Committee") was formed to review and select CDBG eligible youth enrichment programs from the proposals that were submitted totaling \$103,153 (see Attachment #2). The Committee was comprised of six members from the community with diverse backgrounds and extensive years of experience in the field of youth development. Additionally, they are familiar with the community based organizations serving the Oxnard area. A youth representative also served on the Committee.

The Committee's selection of the proposals was based on the criteria set forth by the Department of Housing and Urban Development (HUD) to benefit very low and low-moderate income persons, determined either on an individual basis or by area census tract. **000071**

Proposals submitted were required to demonstrate new or enhanced services to at-risk youth in one of the following priority areas:

- (1) Educational enhancement (tutoring, remediation in basic skills),
- (2) Employment educational training (resume writing, career development, job skills training, etc.),
- (3) Specialized programs focusing on youth services clients of the juvenile justices system, and
- (4) Family counseling and parenting skills training for families with identified at-risk youth in the home.

The proposals selected by the Committee for City Council's consideration demonstrated best evidence-based practices. The three proposals include:

In order to insure compliance with all federal, state and local regulations, proposals were screened by the City's Grants Management office.

If approved, staff will prepare and execute CDBG subrecipient agreements with the three grantees.

FINANCIAL IMPACT

As part of the FY 06-07 budget, City Council approved \$68,597 in CDBG funds (account number 285-5312-804-8209) to disburse to non-profit community based organizations that provide activities for at-risk youth and that participated in the RFP process. Staff is requesting Council's approval of the Committee's selection and recommendation to award grants to three non-profit community based organizations totaling \$68,597.

In additional, PAL hosted two of the largest boxing tournaments, during the past year. PAL has also partnered with the Probation Agency to provide opportunities for youth to complete probation hours.

The Center is well known throughout the United States and Mexico. It has brought significant recognition and fame to the City.

Over 70% of the children enrolled at each school site also participate in the Free and Reduced Lunch Program, which serves families that come from very low, low, and low to moderate income families.	
	In addition to the seven CDBG funded schools, a partnership between the Oxnard School District and the City of Oxnard was formed to provide services to an additional 13 schools using other Federal and State Grant Funds. Three additional schools receive general fund monies. Two of those schools are fee based while the other is contracted out to Camp Fire USA.

Introduction:

In 1993-94, City Council made an important investment into the future, when it decided to set aside 15% of its City CDBG entitlement (the maximum funding allowed by HUD) for Public Service Programs that target at-risk youth. From the beginning, the City Council's goal has been to work closely with community organizations, through both a formal and an informal basis to effectively reach out to and service youth and their families.

The CDBG Public Service Program funding is distributed among a number of youth development programs including the Police Activities League, the Colonia Gymnasium, the Colonia Boxing Center, the After School Program, City Corps and the Youth Enrichment Program (YEP).

The Youth Enrichment Program uses a bid process, established in FY 93-94, to allocate CDBG public service funding to community based organizations for services including educational enhancement; employment education/training; specialized programs focusing on youth services clients of the juvenile justice system; and family counseling and parenting skills training for families with identified at-risk youth in the home. The YEP Request for Proposals (RFP) Process assures access to high quality programs and it is essential to promoting collaboration across disciplines and service delivery systems. (See Attachment A for prior year agency awards).

Phase 1 of the Selection Process:

Notice

For the FY 06-07 process, the City prepared a press release inviting community based organizations to participate in the YEP RFP process. The press release was sent to STAR and Vida newspaper for publications. On Thursday, September 7, 2006 a copy of the press release was mailed to over 100 youth serving agencies that were retrieved from the Interface Blue Book Ventura County Community Resource Directory for 2006. On September 11, 2006 the RFP Application Packet were made available on the City's website, and on CDs at the City Recreation and Community Services offices.

Mandatory Technical Assistance Meeting

A mandatory technical assistance meeting was held on Monday, September 18, 2006. The purpose of the meeting was to inform interested agencies about the Federal, State and local requirements that must be met under the YEP RFP process. The agencies were also provided with the funding priority areas the YEP was looking to fund. Agencies were given complete instructions on the submittal of the application packet. Staff was available for questions. RFP application packets were also available at the mandatory meeting. Ten agencies attended the mandatory meeting.

Review of the YEP application packets

RFP application packets were due on Tuesday, October 10, 2006. The applications packets were checked for compliance with federal HUD regulations and standard City Policies. For example, proposals must demonstrate that:

- Activities fall under one of the funding priority areas;
- A system is in place to verify, either by individual or area census tract, that participants benefiting from the program come from very low, low to moderate income families;
- Activities serve at-risk youth
- Agencies have identified a 50% match in cash or inkind contributions
- Agencies have the required Insurance Coverage
- A copy of the agency's Articles of Incorporation/Bylaws is included
- A copy of the agency's Federal and State Nonprofit Status is included
- A List of Current Board of Directors is included
- Agencies have obtained an Oxnard Business License
- An Independent Audit is included

City also requires that proposals provide a work plan with identified personnel. A detailed budget, approved and signed by the Board of Directors, is closely reviewed. Agencies must confirm they use standard accounting practices in their fiscal recording keeping. A copy of the most current set of financial records, which are reviewed annually by an independent auditor must be included.

In addition, staff evaluates proposals to determine if a justifiable cost-benefit ratio exists.

After completing the 1st phase of the selection process, it was determined that five of the six proposals submitted would move forward to phase 2 as shown on the following table:

The Citizens Ad Hoc Review Committee was formed to review the CDBG Youth Enrichment Program application packets. The six Committee members come from diverse backgrounds and experiences. All of them have a strong interest in youth. A youth representative was present.

As part of their preparation, the Committee was presented with the same "CDBG Youth Enrichment Program" power point presentation made to the nonprofit agencies at the mandatory technical assistance meeting. The Committee's task was to find proposals and agencies that further build on existing community capacity and the successes of the past.

Committee members are provided with rating sheets to use to evaluate the agencies and their proposals in the following areas:

- Ability to comply with CDBG regulations,
- Nature and extent of youth at risk needs to be addressed,
- Extent to which proposed activities meet those needs,
- Ability of agency to carry out the proposed activities,
- Past experience and consistency with HUD and other federal grants and regulations,
- Ability to provide matching funds,
- Proposed activities are not a duplication of existing services,
- Clarity of proposal, and
- Demonstrated linkage with other service providers

After listening to the different presentations made by the agency representatives, the Committee and City staff was given an opportunity to ask questions to clarify certain points. The Committee members scored each of the agencies through the use of a confidential number assigned to each of them.

City staff entered all scores into a matrix. The Committee reviewed the results and took a vote on which proposals would be recommended to City Council for consideration to receive a grant award.

Five agencies were given an opportunity to present their proposals to the Committee. Of the those agencies, only three were selected to receive CDBG Youth Enrichment Program funding for FY 06-07 as shown on the following table:
