SUBJECT: PW07-06 Sea View Estates Neighborhood Resurfacing Project

RECOMMENDATION

That City Council approve Project Specification No. PW07-06 for pavement resurfacing, sidewalk, curb and gutter repair, and replace street name signs throughout the Sea View Estates Neighborhood bounded by Wooley Road, Dunkirk Drive, Victoria Avenue, and Patterson Road.

DISCUSSION

The specific work includes the furnishing of all materials, tools, equipment, and labor required to make necessary repairs to sidewalk, curbs, gutters and other concrete structures, pavement resurfacing, traffic markings, and install new street name signs.

FINANCIAL IMPACT

The engineer's estimated cost for the project, which includes design, material testing, construction inspection, project management, administration, construction engineering, and construction, is \$2,463,349. The project is funded by the Gas Tax Bond and will be awarded after the bond funding is available. Funding will be transferred to the Sea View Estates Neighborhood Resurfacing Project 073104, upon award of the contract.


