COMMENDING JOHN C. ZARAGOZA FOR TWELVE YEARS

WHEREAS, John C. Zaragoza has faithfully served the residents and businesses of the Oxnard community as a Councilmember on the Oxnard City Council since he was elected in 1996; and served as Mayor Pro Tem in 1998; and

WHEREAS, John C. Zaragoza has distinguished himself as a valued leader who consistently brought a high level of enthusiasm and energy to his office, and who worked many long hours on behalf of the residents of Oxnard; and

WHEREAS, John C. Zaragoza has contributed greatly to the City as a member of the Oxnard Housing Authority, Community Development Commission, and numerous boards, commissions and committees including Las Cortes, Inc. Zaragoza has been active in local government and helped bring to fruition numerous projects, including the Del Norte Regional Transfer Station, actively supported the River Ridge Golf Course, the new Esplanade Power Center, new South Oxnard Library, the Anti-Graffiti Program, the recreational component for after-school programs, significant affordable housing projects, Dallas Cowboys spring training program, College Park Skateboard Park, the Police Activities League (PAL) program and preservation of the Ormond Beach Wetlands area.

WHEREAS, John C. Zaragoza was born in Ventura County and is an Oxnard businessman and has participated in numerous local organizations contributing to the betterment of our community, including the Oxnard Chamber of Commerce, Hispanic Chamber of Commerce of Ventura County, Oxnard Kiwanis, Oxnard Board of Realtors, and Sunset Little League Board.


