SUBJECT: Amendment to Ordinance Regarding Bingo Prize Awards

RECOMMENDATION

That City Council approve the first reading by title only and subsequent adoption of an ordinance that amends section 10-23 of the Oxnard City Code regarding the maximum amount of prizes awarded during any single bingo game.

DISCUSSION

The State of California increased the maximum amount of prizes that could be awarded during any single bingo game from \$250 to \$500 effective January 1, 2009. The proposed ordinance would amend the City Code so it is consistent with State law.

FINANCIAL IMPACT

There is no financial impact.

ORDINANCE OF THE CITY OF OXNARD

ORDINANCE NO. __

ORDINANCE OF THE CITY COUNCIL OF THE CITY OF OXNARD AMENDING SECTION 10-23 OF THE OXNARD CITY CODE CONCERNING THE MAXIMUM AMOUNT OF PRIZES AWARDED DURING ANY SINGLE BINGO GAME

The City Council of the City of Oxnard does ordain as follows:

Part 1. Section 10-23 is hereby amended to read as follows:

“SEC. 10-23. MAXIMUM AMOUNT OF PRIZES.

The total fair market value of prizes awarded during any single bingo game shall not exceed \$500.”

Part 2. Within 15 days after passage, the City Clerk shall cause this ordinance to be published one time in a newspaper of general circulation within the city. Ordinance No. ___ was first read on _____, 20__ and finally adopted on _____, 20__ to become effective thirty days thereafter.


