SUBJECT: Establishment of Fees for Parks Services and Permits for Rio Lindo Park

RECOMMENDATION

1. Hold a public hearing to receive public testimony regarding proposed new fees for the use of two group BBQ areas at Rio Lindo Park.
2. Adopt a resolution establishing the proposed new fees.

DISCUSSION

Currently, the Rio Lindo Park BBQ areas are on a first come first serve basis. During the recent renovation to the park, the Rio Lindo Neighborhood Council requested that an additional group BBQ area be built, and that the original group BBQ be relocated to the east side of the park. Both BBQ areas are now on the east side of the park. The Neighborhood Council also asked that both of the group BBQ areas be on a reservation only basis. The establishment of a reservation fee will cover the cost of additional cleaning of the BBQ areas.

DISCUSSION

It was suggested by the Neighborhood Council that the reservation fee should be \$50 with a \$50 security deposit. They also requested that each group BBQ area be reservable for groups of 35 or less.

FINANCIAL IMPACT

The recommended fees will allow recovery of the cost of providing services for private benefit.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OXNARD
ESTABLISHING FEES FOR PARKS SERVICES AND PERMITS FOR RIO LINDO
PARK

WHEREAS, fees for City services and permits are established at the level necessary to recover no more than the City's costs of providing such services and permits; and

WHEREAS; use by the public of the Rio Lindo group BBQ areas involves costs to maintain the area for such use; and

WHEREAS, the General Services, Parks Division has provided a cost analysis of the proposed fees for service, recommending that fees be set in the amounts stated in this resolution; and

WHEREAS, the adoption of such fees is exempt for the California Environmental Quality Act as the establishment of fees for the purpose of meeting operating expenses, including employee wage rates and fringe benefits; and

WHEREAS, notice was given of the proposed adoption of the fees set by this resolution and a public hearing was held thereon, as required by law.

NOW, THEREFORE, the City Council of the City of Oxnard resolves:

1. That the fees adopted by this resolution are for the purpose of meeting operating expenses, including employee wage rates and fringe benefits, as set out in the cost analysis provided by the General Services, Parks Division.

2. That the following fees are hereby adopted for the use of Rio Lindo Park Group BBQ Areas:

Fee for Use of Rio Lindo Park Group Barbeque Areas

\$ 50.00 rental fee per rental of one BBQ area

\$ 50.00 cleaning deposit per rental of one BBQ area


