THE CITY COUNCIL OF THE CITY OF OXNARD DOES HEREBY RESOLVE TO COMMEND ANDRES HERRERA FOR EIGHT YEARS OF DEDICATED PUBLIC SERVICE AS A MEMBER OF THE OXNARD CITY COUNCIL

WHEREAS, Andres Herrera has faithfully served the residents and businesses of the Oxnard community as a Councilmember on the City Council since he was elected in 2002 and served as Mayor Pro Tem from 2004 to 2006 and again from 2008 to 2010; and
